

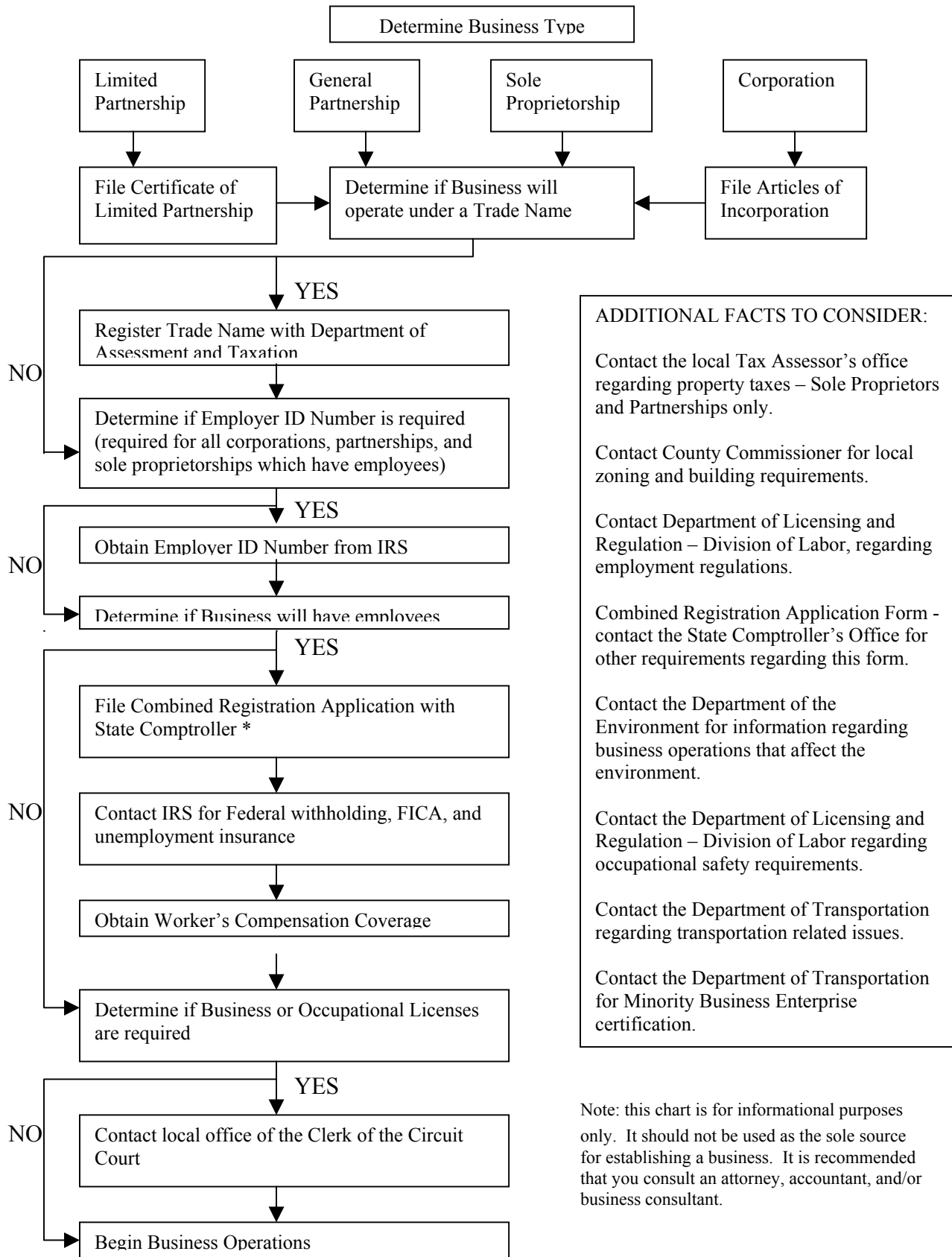
OCCUPATIONS REQUIRING MARYLAND STATE LICENSING

ADDITIONAL FACTS TO CONSIDER:

- Contact the local Tax Assessor's office regarding property taxes – Sole Proprietors and Partnerships only.
- Contact County Commissioner for local zoning and building requirements.
- Contact Department of Licensing and Regulation – Division of Labor, regarding employment regulations.
- Combined Registration Application Form - contact the State Comptroller's Office for other requirements regarding this form.
- Contact the Department of the Environment for information regarding business operations that affect the environment.
- Contact the Department of Licensing and Regulation – Division of Labor regarding occupational safety requirements.
- Contact the Department of Transportation regarding transportation related issues.
- Contact the Department of Transportation for Minority Business Enterprise certification.
